THE EASTER VIGIL: The first Mass of Easter, the Easter Vigil, falls between nightfall of Holy Saturday, 3 April and daybreak of Easter Sunday, 4 April 2010. The *General Norms for the Liturgical Year and the Calendar*, no. 21, states:

The Easter Vigil, during the holy night when Christ rose from the dead, ranks as the “mother of all vigils.” Keeping watch, the Church awaits Christ’s resurrection and celebrates it in the sacraments. Accordingly, the entire celebration of this vigil should take place at night, that is, it should either begin after nightfall or end before the dawn of Sunday.

Individual parishes can check the following website to determine nightfall within the time zone your county is observing on 11 April: <http://www.usno.navy.mil/USNO/astronomical-applications/data-services/rs-one-day-us>. **On this website nightfall is listed as “End civil twilight.” N.B. In the Archdiocese of Indianapolis the Easter Vigil may not begin before nightfall even for pastoral reasons. It may begin later. It must conclude before daybreak on 4 April 2010.**

HOLY DAYS OF OBLIGATION: In addition to Sunday, the days to be observed as holy days of obligation in the Latin Rite are five since, in the Province of Indiana, the **Solemnity of the Ascension has been permanently transferred to the following Sunday (This year this Solemnity will be celebrated on Sunday, May 16, 2010.)**

The additional holy days of obligation in 2010 are:

01 January: The Octave Day of Christmas: The Blessed Virgin Mary, the Mother of God, solemnity

08 December: The Immaculate Conception of the Blessed Virgin Mary, solemnity

25 December: The Nativity of the Lord (Christmas), solemnity

The NCCB decree of 13 December 1991, confirmed by the Apostolic See on 04 July 1992, stipulates that whenever 01 January, 15 August, or 01 November falls on a Saturday or on a Monday, the precept to attend Mass is abrogated.

RITUAL MASSES: Ritual Masses are prohibited on the Sundays of Advent, Lent and the Easter season, on all solemnities (of precept or not of precept, on days within the octave of Easter, on the Commemoration of All the Faithful Departed (All Souls), on Ash Wednesday, and during Holy Week. In addition, the norms in the ritual books or in the Masses themselves also apply [*General Instruction of the Roman Missal*, no. 330].

Rite of Marriage:

“Weekend wedding masses are normally to be celebrated prior to any Saturday evening masses of anticipation. For exceptional Saturday night or Sunday wedding masses, consult the Sacramentary for the appropriate prayers and readings.” (Rituals Masses, IV, 1) *Sacramental/Liturgical Policies, Archdiocese of Indianapolis, 9560.52*

If the marriage is celebrated on a Sunday or solemnity, the Mass of the day is used with the nuptial blessing and the special final blessing according to the circumstances.

When the wedding Mass may not be held, one of the readings from the texts provided for the marriage celebration (nos. 67-105) may be chosen, except from Holy Thursday to Easter, on the solemnities of Epiphany, Ascension, Pentecost, or the Most Holy Body and Blood of Christ, or on holy days of obligation.

However, the Rite of Marriage outside Mass may be celebrated on the above days except during the Easter Triduum.

On the Sundays of the Christmas season and in Ordinary Time, the entire wedding Mass may be used in Masses that are not parish Masses.

When a marriage is celebrated during Advent or Lent or other days of penance, the special nature of these liturgical seasons are to be considered [*Rite of Marriage*, no. 11].

FUNERAL MASSES: Funeral Masses are not permitted on solemnities that are holy days of obligation, Holy Thursday, the Easter Triduum, and the Sundays of Advent, Lent and the Easter season [*General Instruction of the Roman Missal*, no. 336]. Do note, however, that on days when Funeral Masses are not permitted, it may be possible to use the Rite of Funerals Outside of Mass.

Other days of particular note in the Archdiocese of Indianapolis are included as well.

Where reference is made to the ORDO 2010, this refers to “The Order of Prayer in the Liturgy of the Hours and Celebration of the Eucharist 2010”, Dioceses of the Province of Indiana.

At the vigil Mass and Masses for Sunday, December 12, the Third Sunday of Advent is celebrated. Our Lady of Guadalupe may be appropriately honored in one or more of the petitions of the Prayer of the Faithful, in the homily, and perhaps in one of the hymns during the liturgy. The readings and Mass formulary for December 12 are those for the Third Sunday of Advent.

21 December, Monday, **Anniversary of the Dedication of SS. Peter and Paul Cathedral**

feast

solemnity in the Cathedral only

25 December, Friday, **The Nativity of the Lord (Christmas)**

solemnity

holy day of obligation

ritual Masses are not permitted

a funeral Mass is not permitted

27 December, Sunday, **Holy Family of Jesus, Mary, and Joseph**

feast

JANUARY 2010

1 January, Friday, **The Octave Day of Christmas: The Blessed Virgin Mary, the Mother of God**

solemnity

holy day of obligation

ritual Masses are not permitted
 a funeral Mass is not permitted
 Day of Prayer for World Justice and Peace

10 January, Sunday, **Anniversary of the death of Edward T. O'Meara**, 10th bishop/4th archbishop

10 January, Sunday, **Baptism of the Lord**
 feast

11 January, Monday, Ordinary Time begins (1st Week)

22 January, Friday, **Day of penance for violations to the dignity of the human person committed through acts of abortion, and of prayer for the full restoration of the legal guarantee of the right to life** (GIRM, 373.)

Ritual mass "For Peace and Justice" (no. 887-891) may be celebrated.

Violet vestments should be worn for this mass.

Candles may be blessed this day as a part of the principal liturgy. See the Sacramentary for a description of this rite.

14 February, Sunday, **Sixth Sunday in Ordinary Time**

Rite of Election and Call to Continuing Conversion 2:30 PM, SS. Peter and Paul Cathedral

the parish **Rite of Sending to the Bishop** may be celebrated at a time prior to the diocesan Rite of Election and Call to Continuing Conversion [RCIA, no. 108]

17 February, Wednesday, **Ash Wednesday**

ritual Masses are not permitted

a funeral Mass is permitted

Anniversary of the death of Paul C. Schulte, 8th bishop/2nd archbishop

21 February, Sunday, **First Sunday of Lent**

Rite of Election and Call to Continuing Conversion

2:30 PM and 6:30 PM, SS. Peter and Paul Cathedral Church

the parish **Rite of Sending to the Bishop** may be celebrated at a time prior to the diocesan Rite of Election and Call to Continuing Conversion [RCIA, no. 108]

28 February, Sunday, **Second Sunday of Lent**

Penitential Rite - optional rite for baptized but uncatechized adults and children of catechetical age

MARCH 2010

2 March, Tuesday, **Anniversary of Episcopal Ordination of Archbishop Buechlein, O.S.B. (1987)**

7 March, Sunday, Third Sunday of Lent

First Scrutiny with the Elect. Year A readings and ritual prayers are to be used for the Mass of the Scrutiny with the Elect, and may be used at the other Masses as well.

Presentation of the Creed is not celebrated on Sunday but at Mass within the Third Week, unless it was anticipated prior to Lent

14 March, Sunday, Fourth Sunday of Lent

Second Scrutiny with the Elect. Year A readings and ritual prayers are to be used for the Mass of the Scrutiny with the Elect, and may be used at the other Masses as well.

19 March, Friday, Saint Joseph, Husband of the Blessed Virgin Mary

solemnity

ritual Masses are not permitted

however, marriage may be celebrated within the Mass of the day. One reading from the ritual may be substituted, and the nuptial blessing is used

a funeral Mass is permitted

patronal feast of Pope Benedict XVI, prayers may be included in the general intercessions

21 March, Sunday, Fifth Sunday of Lent

Third Scrutiny with the Elect, Year A readings and ritual prayers are to be used for the Mass of the Scrutiny with the Elect, and may be used at the other Masses as well.

Presentation of the Lord's Prayer is not observed on Sunday but at Mass within the Fifth Week unless it was anticipated prior to Lent or deferred to the **Preparation Rites on Holy Saturday** during the day

25 March, Thursday, The Annunciation of the Lord

solemnity

ritual Masses are not permitted

however, marriage may be celebrated within the Mass of the day, one reading from the ritual may be substituted, and the nuptial blessing is used

a funeral Mass is permitted

28 March, Sunday, Palm Sunday of the Lord's Passion

Holy Week begins

29-31 March, Monday-Wednesday, Weekdays of Holy Week

ritual Masses are not permitted

however, marriage may be celebrated within the Mass of the day, one reading from the ritual may be substituted, and the nuptial blessing is used

a funeral Mass is permitted

30 March, Tuesday of Holy Week, Chrism Mass

7:00 PM, SS. Peter and Paul Cathedral

APRIL 2010**1 April, Thursday of Holy Week, morning and afternoon**

the only Mass permitted is the Evening Mass of the Lord's Supper

a funeral rite (Liturgy of the Word, closing with the rite of Farewell; cf. OCF part I, no. 4) may be celebrated, with the readings reflecting the nature of this day. Communion is not given.

1-4 April, Holy Thursday evening through Easter Sunday, **The Easter Triduum**

ritual Masses are not permitted

the sacraments are not celebrated except the non-communal forms of penance and anointing of the sick, and the sacraments of initiation within the Masses of Easter

a funeral Mass is not permitted. A funeral rite (Liturgy of the Word, closing with the rite of Farewell; cf. OCF part I, no. 4) may be celebrated, with the readings reflecting the nature of these days. Communion is not given.

5-11 April, Monday through Sunday, **Days within the Octave of Easter**

solemnities

ritual Masses are not permitted

however, marriage may be celebrated within the Mass of the day, one reading from the ritual may be substituted, and the nuptial blessing is used

a funeral Mass is permitted on Monday through Saturday only

MAY 2010

16 May, Sunday, **The Ascension of the Lord**

solemnity

replaces the Seventh Sunday of Easter in the Province of Indiana

ritual Masses are not permitted

a funeral Mass is not permitted

23 May, Sunday, **Pentecost Sunday**

solemnity

proper Vigil Mass

ritual Masses are not permitted

a funeral Mass is not permitted

24 May, Monday, **Ordinary Time resumes, 8th Week**

30 May, Sunday, **The Most Holy Trinity**

solemnity

ritual Masses are not permitted

JUNE 2010

6 June, Sunday, **The Most Holy Body and Blood of Christ**

solemnity

ritual Masses are not permitted

10 June, Thursday, **Anniversary of the death of Joseph Elmer Ritter, 7th bishop/1st archbishop**

26 June, Friday, **Anniversary of the death of Servant of God Simon Brute**, 1st bishop

29 June, Tuesday, **Peter and Paul, Apostles**
solemnity
patronal feast of the Cathedral of Indianapolis
ritual Masses are not permitted

JULY 2010

the special Independence Day Mass is not used in place of the Ordinary Sunday

ritual Masses are not permitted

9 September, Wednesday, **Anniversary of the installation of Archbishop Daniel Mark Buechlein, O.S.B. (1992)**

OCTOBER 2010

03 October, Sunday, **Saint Theodora Guérin, virgin, Principal Patroness of the Archdiocese**
not observed this year

17 October, Saturday, **Twenty-ninth Sunday in Ordinary Time**
Anniversary of the death of George Joseph Biskup, 9th bishop/3rd archbishop

NOVEMBER 2010

01 November, Monday, **All Saints**
Solemnity (not a holy day of obligation this year)
ritual Masses are not permitted
however, marriage may be celebrated within the Mass of the day, one reading from the ritual may be substituted, and the nuptial blessing is used
a funeral Mass is permitted

02 November, Tuesday, **The Commemoration of All the Faithful Departed (All Souls)**
White, violet or black vestments may be worn

ritual Masses are not permitted
a funeral Mass is permitted

16 November, Tuesday, **Anniversary of Dedicated Churches**
Solemnity (observed in these churches only)

25 November, Thursday, **Thanksgiving Day**
for options see ORDO 2010
