# Making the Most of the Opportunity

Kate\* came to Becky's Place from a local shelter that was closing. She had no other options but was thankful to arrive at Becky's Place. She immediately wanted to contribute to our program and started helping with the Becky's Place store. Our store provides hygiene items, clothing, household supplies and much more for the women we house. All residents earn "Becky Bucks" to spend at the store by completing goals, and the store is used to teach life-skills, budgeting and meet needs. Kate was eager to assist with this project and was an amazing addition to the house.





Kate shared that she has PTSD and anxiety from childhood trauma, and this had prevented her from finding and maintaining employment in the past. Kate's case managers worked with her to address past struggles, and she began attending counseling regularly and taking appropriate medications to aid in her recovery.


Kate diligently applied for housing and employment daily and was eventually offered a job at a local flower shop. After working there temporarily, her case manager heard of a job opening in the next county for a property manager position that included housing and a stipend. Kate immediately applied and was offered the position and an on-site apartment. She has been successfully living and working at her new job for a few months, and we are proud of her persistence. She continues working with her case manager from Becky's Place and is thankful for all the opportunities she has been given.

### **Resident Update**

We are currently serving 17 residents and three children. Becky's Place continues to serve as an unofficial call center for our community, answering 2-3 calls every day from women – and men – seeking resources for a myriad of challenges. Becky's Place currently has two past residents that are regularly volunteering and continuing to thrive on their journey. One past resident is pursuing her GED in hopes to move forward to college. They are both sharing their knowledge and experience with the current residents.




## **Becky's Place Receives Generous Grant Funds**

In July, Becky's Place received a \$30,000 grant from United Way of South Central Indiana. These funds were part of an Economic Relief Initiative Grant that was awarded to United Way of South Central Indiana through a partnership between Lilly Endowment Inc. and Indiana United Ways. The funds were a huge blessing and were used to help with the operational expenses of the shelter.

Becky's Place also recently received a \$10,000 grant from Wireless Zone Foundation for Giving. This grant allowed for some needed updates at Becky's Place. Our residents now having new bedding, alarm clocks, hampers and much more. We had the opportunity to replace old/broken office equipment with new fully-functioning items and will be getting some beautiful patio furniture and gardening supplies to start a new project! We would like to thank these two great organizations for their generous support in providing help and creating hope for homeless women and children in our community.

The Lawrence County Community Foundation awarded Becky's Place \$5,000 from an IU Health Grant to help residents entering the workforce. These funds will assist with obtaining required documentation and work wardrobe needs. It will also help to purchase a computer that will allow residents to attend virtual support groups, create resumés and participate in virtual job interviews.

## **IRA Giving**

Qualified Charitable Distributions (QCDs), through an individual retirement account (IRA), have become a very popular method of giving. Donors 70 ½ and older may use qualified QCDs to donate up to \$100,000 per year to the charity of their choice, and receive unique tax benefits. At age 72, these donations count as required minimum distributions. QCD gifts can be made to benefit annual funds or appeals, capital campaigns and endowments.
