


Dear Brothers and Sisters in Christ:

I am pleased to share with you this FY 2022 Annual Report for the Catholic Community Foundation of the Archdiocese of Indianapolis. We continue to be incredibly blessed by so many generous people who care deeply about the parishes, schools, agencies, ministries and programs of our Church in central and southern Indiana.

As the old saying goes, "it takes a village." And indeed it does. We live in a very challenging culture, which makes advancing the mission of the Church more important than ever. I'm thankful for those who understand the need for Catholic schools; strong, healthy parishes; programs for our youth and young adults; the support of our many Catholic Charities agencies; and the formation of our deacons and our seminarians. They continue to put faith into action, providing for the growing needs of God's people.

In the fiscal year ending June 30, 2022, we added 14 new endowment funds and five new donor advised funds, increasing the foundation's number of funds to 569 and net assets to more than \$206 million. Distributions from these funds provided more than \$9.8 million to our parishes, schools, agencies and ministries. These distributions were possible only because an individual, family or group of people wanted to make sure the ministry areas they are/were most passionate about would be supported for many years to come - even after they are gone.

I admire the dedication and service of the members of the Catholic Community Foundation Board of Directors, and those involved in the supporting committees. They lead by example, are great witnesses of Christ's love, and are responsible stewards of the Catholic faith.

And I admire you for contributing to the good works that are noted throughout this annual report. You are making a tremendous impact on the Church, and join many others who have decided to leave a legacy for future generations. Thank you for trusting the Catholic Community Foundation to oversee your legacy.

The Roman Catholic Archdiocese of Indianapolis comprises 126 parishes, 67 schools, six Catholic Charities agencies and many offices of ministry across 39 counties in central and southern Indiana, covering a total area of 13,757 square miles. The archdiocese is comprised of eleven deaneries. The deaneries join together multiple parishes. Below is a list of the deaneries showing how much endowment distributions each received in FY 2022.

Distributions are to be used to provide financial support for the maintenance and care of Immaculate Conception Parish Cemetery, Millhousen.

Distributions are to be used for the care and maintenance of St. Anne Cemetery, Oldenburg.

Distributions are to be used to provide support for the ongoing maintenance of the St. Anne Cemetery, Oldenburg.

Distributions are to support St. Charles Borromeo Cemetery and St. Pius Cemetery.

St. Denis Cemetery Endowment Fund - Jennings County (V: \$92,514 D: \$-4,991)

Established by Charles W. Schwering. Distributions are to be used for the care and maintenance of St. Denis Cemetery, Jennings County.

St. Denis Parish Endowment Fund - Jennings County (V: \$11,106 D: \$-599)

Established by Charles W. Schwering. Distributions are to be used to provide support for St. Denis Parish, Jennings County.

St. John Catholic Church - Msgr. John J. Minta Education and Building Endowment Fund (V: \$9,974 D: \$-530)

Established in memory of Msgr. John J. Minta, pastor of St. John, Osgood from 1980-1995 with his estate funds. Distributions are to be used to supplement the educational and building/grounds needs of St. John Catholic Church, Osgood.

Established by St. John Parish, Osgood to assist families in need.

Distributions are to be used for the maintenance and other needs of St. John the Baptist Cemetery, Dover.

Distributions are to be used to provide funds for the perpetual care, lawn service and general maintenance of St. John the Baptist Parish Cemetery, Dover.

St. Lawrence - Lawrenceburg School Endowment Fund (V: \$330,847 D: \$-17,261)

Distributions are to be used for the general needs of St. Lawrence School, Lawrenceburg.

St. Lawrence - Sister Mary Cecile Deken Religious Education Endowment Fund (V: \$18.294 D: \$-964)

Distributions are to be used to provide funds for any parish/school religious education related program or event for children, youth or adults attending St. Lawrence Catholic Church, Lawrenceburg.

St. Lawrence Parish General Endowment Fund

(V: \$188.503 D: \$-9.936)

Distributions are to be used for the operation and capital needs of St. Lawrence Parish, Lawrenceburg.

St. Louis Parish Cemetery Endowment Fund

Distributions are to be used primarily to provide care and maintenance along with its operating and capital needs at St. Louis Parish Cemetery, Batesville.

Distributions are to be used for the operating and capital needs of St. Louis Parish, Batesville.

St. Louis Parish Endowment Fund - Fr. Herculan Scholarship (V: \$41,921 D: \$-2,262)

Distributions are to be used to provide Catholic high school tuition assistance for students attending St. Louis Catholic School, Batesville.

St. Louis School - The Ben and Lorraine Dierckman Family Endowment (V: \$145,617 D: \$-7.856)

Distributions are to be used to assist on a long-term basis with the annual operating expenses at St. Louis School, Batesville.

Established from the real estate of Mr. and Mrs. John F. Lynch. Distributions are to be used to provide reimbursement for the spiritual renewal of educators and parish catechists in appreciation of their service to the children of our faith community at St. Michael School. Brookville.

St. Michael School Endowment Fund - Keith and Ruth Banning Scholarship (V: \$16,812 D: \$-865)

Distributions are to be used to provide scholarship tuition for children in need who will attend the Oldenburg Academy of the Immaculate Conception, and are graduates of St. Michael School, Brookville.

St. Nicholas Heritage Endowment Fund (V: \$132,229 D: \$0)



The Kruer family has since created an endowment (on page 28 of this report) to help others with scholarships to attend, as they firmly believe in the importance and value of a Catholic education. Through their contributions to their family endowment that will support needs of students long into the future, as well as their gifts to the United Catholic Appeal each year, the Kruers story is one that truly embodies the Circle of Giving - providing for the Church today and always.



Bond between a family and a Catholic school has grown every year for seven decades

As they worked together on their farm in southern Indiana, Ambrose and Mary Rose Kruer knew the power and wonder of seeds—how something so small could grow into something so sustaining and life-giving.

As the parents of 11 children, Ambrose and Mary Rose also believed there were certain seeds that needed to be planted in their offspring's lives—the strength of family, the foundation of the Catholic faith and the opportunity

of a Catholic education.

So when the oldest of their children, Evelyn, was ready to go to high school in 1951, Ambrose and Mary Rose considered it a gift from God when Our Lady of Providence High School in Clarksville opened that same year, giving Catholic youths in the southern part of the archdiocese a place to continue their Catholic education.

What Ambrose and Mary Rose never imagined is how that shared beginning for a family and a school would grow into something wondrous.

Consider this reality: Ever since Evelyn attended Providence in the fall of 1951, at least one descendant of Ambrose and Mary Rose has been a student at the school in each of its 70 years of existence.

A family and a school bound tightly together for seven decades.

Creating a Legacy

"My parents had 11 children who all attended Providence," says Norman Kruer, the sixth of the 11 children and a 1963 graduate of the school. "They also had 34 grandchildren who all attended Providence. There have been 19 great-grandchildren who have gone or are now going to Providence through the 2023-24 school year."

Norman isn't done: "Two additional great-grandchildren will be starting at Providence for the 2022-23 school year, which currently will continue the legacy through the 2025-26 school year. Then, of course, there are great-great-grandchildren on the way."

The start of that legacy came with a challenge. To get to Providence from the family's farm in the community of Starlight, Evelyn had to take two school buses. Then she entered a cab, which was paid for by one of the pastors in the area, to complete the journey to school.

That's how much it meant to their parents to have their children get a Catholic education.

"They were strong believers in the Catholic faith and the education that went with it," Norman says. "They felt giving us a Catholic education was an obligation. They wanted us to stay in that culture. They believed in Catholic schools, and they passed that onto us, and we passed it on to our children. That's how the legacy was built."

Norman's part in that legacy is an interesting story in itself.

'It felt like home'

There are five descendants of Ambrose and Mary Rose who are currently students at the school: Luke and fellow sophomore Nina Kruer, plus three seniors, Peyton Kruer, Eli Krussow and Grant Williams.

"Providence means a lot to me," Luke says. "Ever since I shadowed here when I was in the eighth grade, it felt like home. Actually, being here at school now is even better. I'm appreciative of all that it offers—great athletics, great academics, great faith."

Similar to Luke, Peyton embraces the family's 70-year connection to Providence. Her grandfather, Merle Kruer, is a 1959 grad and her father, Merle John, Jr., is a 1990 grad. And her sister Madison is a 2019 graduate.

"It honestly feels like an honor being part of a family that's so passionate about this school," Peyton says. "I'm glad I've had the opportunity as well. I really like the environment here. Everyone is nice, there's a positive energy, and everyone is close to one another. It makes a difference."

She especially focuses on the difference that Providence has made in her faith life, with weekly Masses and opportunities for eucharistic adoration.

"It brings me closer to God," she says. "It also brings me closer to my classmates."

Norman Kruer knows that such praise from their great-grandchildren would touch the hearts of Ambrose and Mary Rose.

That feeling flows through him as he considers the legacy of his parents, a legacy that includes other branches of the family tree besides the Kruers—families named Book, Costelle, Holden, Kraft, Krussow, Lilly, McPhillips, Nett, Schellenberger and Williams.

"I think my parents would be surprised that it has continued," Norman says. "It was never on their mind that they were starting a legacy. Still, they'd be proud and appreciative of everything that's been done. And they'd be proud and appreciative of Providence for all it's done for us.

"Our whole family is proud of this legacy."

The seeds of two parents' faith continue to grow in a wondrous way. †

5 Steps for Making Personally Rewarding Gifts

1. DEFINE WHAT YOU WANT TO ACHIEVE

You give because you care and want to help. But it is always a good idea to consider the motivation behind your gift and to be specific about what you want to accomplish. For example:

- Is there a specific area of our work that is most important to you?
- Do you desire to support our work immediately, in the future, or both?
- Do you want to honor or remember someone?

Take the time to thoughtfully consider why you give, remembering that your gift can impact a ministry of the Church that is important to you.

2. COMMUNICATE WELL

Communicating well is an important part of planning and giving, and it deserves thoughtful attention. A gift's impact can be quite broad, and those who are affected can benefit greatly from the information you share. You will personally benefit as well.

First, we strongly encourage you to communicate with us. We are always interested in hearing the motivation behind your gift and how you want it to be used. We can also provide helpful information about ways you can make an impact today and tomorrow.

Second, communicate with your advisors. While some gifts are quite easy for you to plan and complete (outright gifts of cash or stock, for example), you should consult your advisors whenever your gift will have an impact on your financial and estate planning. We are happy to work with you and your advisors to help you explore various gift options and see how they would fit with your overall planning.

Third, communicate with your family and friends. Share your philanthropic pursuits and intentions, particularly when you design your gift to benefit loved ones in specific ways (such as charitable trusts or gifts through your will). When you share the reasons for your charitable giving, you begin to shape your charitable legacy and set an example for others to follow.

Last, once you have finalized your plans, we respectfully ask that you communicate them with us so that we can be sure to follow your intentions when the time comes.

3. KNOW YOUR COMFORT LEVEL

It is important to know your comfort level regarding the amount and timing of your gift. Your first inclination may be to think in terms of doing as much as you can as soon as you can. However, this desire to make an impact must be balanced by what is practical and prudent for your current situation and how you provide for yourself and your loved ones.

Whatever your personal comfort level, there are gift planning options that will work for you. Some donors combine a gift today with a largerplanned gift to be completed in the future. Others appreciate the flexibility of a revocable gift—one you plan today but have the right to change during your lifetime. Common and easy revocable gifts include gifts in your will or living trust and beneficiary designations on a life insurance policy or retirement account. These options let you make a comfortable commitment—an important and rewarding gift that allows you to retain access to gift assets in case you need them.

4. CONSIDER HOW GIVING FITS INTO YOUR PERSONAL PLANNING

Whether you are considering a yearly budget or preparing your will, charitable giving is an important part of your planning. While helping others provides personal satisfaction, it can also play a role in tax-smart strategies that help you and your loved ones.

Meet multiple needs

Thoughtful gift planning makes it possible to meet multiple needs. With one gift plan, you can support the work kof the Church, enjoy a tax benefit, and help loved ones at the same time. Life income gifts such as a charitable gift annuuity (CGA) are the best example of this unique opportunity.

Charitable gift annuities. A charitable gift annuity is designed to pay income to you and/or someone else (two income beneficiaries maximum) for life and ultimately provide a gift to the Catholic Community Foundation. A charitable gift annuity is easy to set up and the residual balance benefits the ministry of your choice.

5. MAXIMIZE THE PERSONAL BENEFITS OF GIVING

Every gift is important—to us and to you. Maximizing the personal benefits of giving can make giving even more rewarding.

- Gifts to qualified charities are eligible for a charitable tax deduction. However, since the Tax Cuts and Jobs Act of 2017 significantly increased the standard deduction, fewer taxpayers itemize their returns. One way to still enjoy the benefits of charitable deductions is to "bunch" donations planned for multiple years into a single year in order to exceed the standard deduction amount. This makes it possible to benefit from the higher standard deduction in some years and enjoy a significant itemized deduction in other years.
- What you give is also an important consideration in your overall planning. For
 example, at your death, every dollar of your retirement account is subject to
 income tax as it is received by heirs. In contrast, heirs who receive appreciated
 stock receive a "step up in basis," meaning they will only pay tax on any
 appreciation that occurs after the date of inheritance. Consequently, when
 choosing how to make a charitable gift through your will and estate planning,
 your heirs can benefit if you give them appreciated stock and use retirement
 assets to make a charitable gift.
- Rethink how you use the Required Minimum Distribution of your individual retirement accounts (IRA) to avoid taxes. Qualified Charitable Distributions (QCDs), through an IRA, have become a very popular giving vehicle. Donors 70 1/2 and older may use QCDs to donate up to \$100,000 per year to the charity of their choice, and receive unique tax benefits. At age 72, these donations county as required minimum distributions. Such gifts can be made to benefit annual funds or appeals, capital campaigns, endowments, and even donations to the Indiana State Tax Credit Program to provide tuition assistance at any of our 67 archdiocesan schools. To take advantage of this benefit, the required minimum distribution must be made directly to a qualified charity.
